

# ZONE 1

MARINA DE VALENCIA

Ramp Kayak fishing Valencia located at La Marina de Valencia, Darsena Sur.









There are two stages, one oriented to the north of the port of Valencia and the other to the south.

#### The latest FIPS-M rules can be downloaded from the FIPS-M website:

#### Rods - Baits.

Only 1 rod with reel may be used when fishing. One spare rod mounted without bass is allowed. It is possible to have other unmounted spare rods.

The baits will be natural, provided by the organisation, if possible, four boxes of Korean and 500 gr. of prawns, and artificial baits provided by the angler may also be used.

#### SCORING SYSTEM

To help preserve the survival of the fish caught, the classification will be based solely on the length of the fish.

The fish are measured in cm, photographed on the measuring rod (controlled by the jury) and released as soon as possible. In order to have the clearest possible picture, the batten must be fixed in the kayak. At the end of each round, the competitors must send the photos to the jury so that they can be transferred to the computer. After viewing the photos, the jury will validate the measurements and establish the ranking.

The delicate capture of a fish can only be done with the help of a dip net, which must not cause injury to the fish.

The minimum size for all fish is 18 cm. Ranking by length (FIPS-M Rules)

- For each legal size fish (≥ 18 cm) ...... 10 Points.
- For every centimetre (1 cm) ..... 1 Point.

Every centimetre started is rounded up.

• For each "Oversize" fish (= larger than 50 cm) a bonus of 50 points is awarded in addition to the points normally awarded.

- In the event of a tie, the angler who has caught the most fish takes first place.
- And then the angler with the longest fish will be considered.

## **ESSENTIAL ANTI-DOPING ADVICE**

Athletes are reminded if they take any medication they must check it against the WADA Prohibited Substance & Methods list.

Particular attention must be paid to the use of anti- hypertensive agents, especially diuretics, which are popular in singular preparation and/or in a combination with other normally permitted drugs.

Diuretics are always forbidden.

For these reasons, it is necessary for every athlete or National Federation to check the list for prohibited substances and process a TUE as necessary. The Therapeutic Use Exemption (TUE) must be granted before taking a prohibited medication.

An application for a TUE must be requested 30 days before taking part in the championships. The application forms must be filled in carefully with your physician/doctor who must authorise the application. A physician's certificate or prescription on its own does not mean that the athlete has permission to use the prohibited substance or method.

The application should be completed either in English or French and sent directly to the office of the CIPS President.
